**ORDER:**

In the letter first read above, the Secretary (FAC), TSPSC has informed that the Telangana State Public Service Commission has been formed and started working from 17.12.2014 F.N. and at present there is no funds allocations in the TSPSC for payment of pay and allowances and other expenditures for smooth functioning of the Commission. He has therefore requested for sanction of an amount of Rs.8.72 Lakhs for the 3<sup>rd</sup> quarter upto December, 2014 and for an amount of Rs.10,04,95,000/- for the 4<sup>th</sup> quarter of the financial year 2014-2015 to the Commission's Office to commence their functions for issue of notifications to achieve the target given by the Government.

In the G.O. second read above, orders have been issued for releasing an amount of Rs. 7,62,95,000/- (Rupees Seven Crores Sixty Two lakhs and Ninety Five Thousand only) as a budget for Telangana State Public Service Commission under Non-Plan from the BE Provision 2014-15 under the following heads of accounts, towards meeting the expenditure from following head of accounts by Telangana State Public Service Commission, in relaxation of Treasury Control and Quarterly Regulation orders pending inclusion in the supplementary estimates 2014-2015.
