If it comes to the notice of the Commission later that any candidate furnished false information or the selection is not in order due to any act of omission or Commission of any candidate then his/her provisional selection is liable to be cancelled at any stage and they will forfeit all consequential benefits

including that of selection. Besides that, the Commission reserves the right to take any action as it deems fit in the circumstances of the case, in terms of the provisions as notified in TSPSC Rules of Procedure published in Telangana State Gazette No.60., Dt: 28/12/2015.

With this Notification of selection, the General Recruitment process notified vide Notification No.13/2017 for the post of Post Graduate Teachers in various Residential Educational Institutions Societies has been finally concluded except Court related issues.

The selections are subject to the final outcome of W.P.s and other cases pending, if any, before the court where similar orders are passed in OA/WP.
