In continuation to the provisional list of selected candidates to the Post of **Secondary Grade Teacher (Telugu Medium) notified vide Notification No.53/2017** for a total no. of 3786 vacancies in School Education Department, published vide Selection notification Dt 11.10.2019. Result of the following provisionally selected **18** candidates which was kept withheld in the selection notification dated: 11/10/2019, in compliance with the Hon'ble High Court orders the WP Nos.23785 of 2018 & 38877 of 2018 wherein the Hon'ble High Court ordered to not to fill up the 22+4 vacancies Now the commission is releasing the result as per the Hon'ble High Court common order on 29/09/2020 in Writ Petition Nos. 15129 of 2020, 23404 of 2019, 24137 of 2019, & 15130 of 2020.

The result of the following provisionally selected **55** candidates was withheld in the earlier results dt:04/04/2019 & 11/10/2019 as their result was subject to clearance of Agency Local Status of meritorious candidates selected in agency areas. The meritorious Agency candidates are confirmed as belonging to agency areas by District Authorities and their reports are received by the TSPSC as stipulated in orders of the Commission dt:16/10/2018 in compliance with the directions of Hon'ble High Court, dt:04/09/2018 in WP Nos 28709, 26195, 26919 of 2018 and in WP No 31426 of 2018, dt:05/09/2018 and in WP No 32413 of 2018, dt:04/09/2018 by constituting the Committee as per G.O.Ms.No.24, dt:12/06/2018.

The selections are published here-with subject to the following conditions.

- 1) That success in the Examination confers no right to appointment unless the appointing authority is satisfied after such enquiry as the case may be considered necessary that the candidate having regard to his/her character and antecedents is suitable in all respects for appointment to the service.
- 2) That the candidates are found physically fit for the post.
- 3) That the candidates should produce such original certificates as required in accordance with the Rules / Notification.

If it comes to the notice of the Commission later that any candidate furnished false information or the selection is not in order due to any act of omission or Commission of any candidate then his/her provisional selection is liable to be cancelled at any stage and they will forfeit all consequential benefits including that of selection. Besides that, the Commission reserves the right to take any action as it deems fit in the circumstances of the case, in terms of the provisions as notified in TSPSC Rules of Procedure published in Telangana State Gazette No.60., Dt: 28/12/2015.

The selections are subject to the final outcome of W.P.s and other cases pending, if any, before the Hon'ble High Court, Telangana State.
