The selection is subject to the following conditions:

- 1) That success in the Examination confers no right to appointment unless the appointing authority is satisfied after such enquiry as the case may be considered
- 2) necessary that the candidate having regard to his/her character and antecedents is suitable in all respects for appointment to the service.
- 3) That the candidates are found physically fit for the post.
- 4) That the candidates should produce such original certificates as required in accordance with the Rules / Notification.
- 5) The allotment of candidates to a local cadre is subject to further procedure according to provisions G.O Ms. No.124, GA (SPF -MC) Department dated: 30.08.2018.
- 6) If it comes to the notice of the Commission later that any candidate furnished false information or the selection is not in order due to any act of omission or Commission of any candidate then his/her provisional selection is liable to be cancelled at any stage and they will forfeit all consequential benefits including that of selection. Besides that, the Commission reserves the right to take any action as it deems fit in the circumstances of the case, in terms of the provisions as notified in TSPSC Rules of Procedure published in Telangana State Gazette No.60., Dt: 28/12/2015.
- 7) In compliance with the orders of Hon'ble High Court in WP No.31426 of 2018 & 31423 of 2018, the selection of ST candidates those who submitted Agency area certificate, is subject to receipt of final report of the appointing authority in terms of G.O Ms. No.24, TW (LTR), dated:12.06.2018.
