

**TELANGANA STATE PUBLIC SERVICE COMMISSION :HYDERABAD  
RECRUITMENT TO THE POST OF STAFF NURSE IN DIRECTOR OF PUBLIC HEALTH &  
FAMILY WELFARE AND TELANGANA VAIDYA VIDHANA PARISHAD (HEALTH,  
MEDICAL& FAMILY WELFARE DEPARTMENT) VIDE NOTIFICATION NO. 57/2017  
(GENERAL RECRUITMENT)**

**WEB NOTE**

The Commission published the List of Provisionally Selected Candidates for the post of Staff Nurse in DPH&FW and TVVP Vide Notification No.57/2017.

The Commission has issued Notification on 08/11/2017 to fill 3311 vacancies in TVVP and DPH & FW Department and conducted CBRT Examination on **11/03/2018**. The Commission has published Preliminary keys on **25/05/2018** and final key was published on **06/07/2018**. According to the Norms of Notifications, to award 30 weightage points to the applicants commission has extended the uploading link to applicants for uploading their service and qualification certificates and the time given for uploading their certificates was extended two more times on the request of applicants and was finally closed on **14/08/2018**. The Commission has forwarded the uploaded certificates link to DPH & FW on 23/08/2018 and to TVVP on 27/08/2018 to verify the service certificates & weightage marks.

Some of the candidates filed various WPs before the Hon'ble High Court against **G.O.Ms.No.166** and awarding weightage marks. And some of the out sourcing candidates also filed various WPs for awarding weightage marks on par with contract Employees. After clearance of court cases in full bench the Hon'ble High Court issued final judgment on **18/09/2020** , after that Commission has issued GRL on **07/11/2020** as well as Certificate Verification List of 3248 Candidates was published for notified vacancies 3311 posts, at the ratio of 1:2.

After issuing the General Ranking List some representations (455) were received to the Commission which were forwarded to Medical and Health Department for reexamination and their remarks. The Medical and Health Department constituted an expert committee reexamine representations and sent a list of 1823 candidates who were eligible for Service Weightage on

**15/12/2020**, and further clarification were received on 30/12/2020, 03/02/2021 and 13/02/2021.

After receiving revised marks , Commission has published **GRL on 22<sup>nd</sup> of February 2021** as well as Certificate Verification List of 3172 Candidates was published for notified vacancies (3311 posts), in the ratio of 1:2. Commission conducted certificate verification from **25/02/2021 to 05/03/2021**. Corrections were carried out after scrutiny by a team of experts who rectified errors in qualification weightage marks.

Further the Commission has called 204 candidates for 2<sup>nd</sup> spell certificate verification in place of absentees on 20/04/2021 & conducted certificate verification on 24/04/2021. After 2<sup>nd</sup> Spell Certificate Verification Commission has issued Provisional Selection List on 29/04/2021 announcing selection of 2418 candidates and 893 vacancies are left unfilled for want of eligible of candidates in respective categories against 3311 Notified vacancies for the post of Staff Nurse in DPH & FW Department and TVVP vide Notification No.57/2017.

**Note: Candidates to note that in view of urgency in forwarding the list to DPH&FW Department and TVVP, the Candidates who were not willing to join this post are required to file the relinquishment immediately i.e., from 29/04/2021 to 01.05.2021 by 12 Noon through Weblink provided on TSPSC Website [www.tspsc.gov.in](http://www.tspsc.gov.in)**
